RELEASE AND LIABILITY WAIVER

Covering Noon Thursday January 5, 2017 – Noon Saturday, January 7, 2016

If you are 18 years old or older, you must read and sign the following waiver before attending the Winter Retreat sponsored by the Heritage Baptist Church of Shreveport, LA.

If you are under 18 years of age, a parent or guardian must read and sign the following waiver before Winter Retreat sponsored by the Heritage Baptist Church of Shreveport, LA.

This Release and Waiver of Liability (the “Release”) executed on this _____ day of _____, 20_____ by _____ (the “Attendee”) from the church name, in favor of the Heritage Baptist Church of Shreveport, LA.

The attendee hereby freely, voluntarily, and without duress executes this Release under the following terms:

1. Release and Waiver. Attendee does hereby release and forever discharge and hold harmless the Heritage Baptist Church, Shreveport, LA, and their successors and assigns from any and all liability, claims, and demands of whatever kind of nature, either in law or in equity, which arise or may hereafter arise from Attendee’s Activities at the Winter Retreat. Attendee understands that this Release discharges the Heritage Baptist Church, Shreveport, LA from any liability or claim that the Attendee may have against the Heritage Baptist Church, Shreveport, LA with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Attendee’s Activities with the Heritage Baptist Church, Shreveport, LA, whether caused by the negligence of the Heritage Baptist Church, Shreveport, LA or its officers, directors, employees, or agents or otherwise. Attendee also understands that the Heritage Baptist Church, Shreveport, LA does not assume any responsibility for, or obligation to, provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

2. Medical Treatment. Attendee does hereby release and forever discharge the Heritage Baptist Church, Shreveport, LA from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Attendee’s Activities with the Heritage Baptist Church, Shreveport, LA.

3. Assumption of the Risk. The Attendee understands that the Activities may include recreation that normally is not considered hazardous to the Attendee, but also realizes any activity may involve possible risks. The Attendee hereby expressly and specifically assumes the risk of injury or harm in these activities and releases the Heritage Baptist Church, Shreveport, LA from all liability for injury, illness, death or property damage resulting from the Activities of the Attendee’s participation with the Heritage Baptist Church, Shreveport, LA.

4. Insurance. The Attendee understands that, except as otherwise agreed to by the Heritage Baptist Church, Shreveport, LA in writing, the Heritage Baptist Church, Shreveport, LA is not obligated to and does not carry or maintain health, medical, or disability insurance coverage for any Attendee. **Each Attendee is expected and encouraged to arrive with medical or health insurance coverage in effect.**

5. Photographic Release. Attendee does hereby grant and convey unto the Heritage Baptist Church, Shreveport, LA all right, title and interest in any and all photographic images and video or audio recordings made by the Heritage Baptist Church, Shreveport, LA during the Attendee’s Activities with the Heritage Baptist Church, Shreveport, LA including any photographs or recordings.

6. Other. Attendee expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Louisiana, and that this Release shall be governed by and interpreted in

accordance with the laws of Louisiana. Attendee agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
